**REGISTRATION PROCESS & PAYMENTS**

**REGISTRATION FEE**

A registration fee must accompany each student's registration form. For new and returning students in Grades K-8, the registration fee is \$125 prior to March 31, 2017 and increases to \$250 per student for returning students thereafter. The registration fee is non-refundable.

**FINANCIAL AID**

In order to qualify for the Parishioner Tuition Rate, you must be a registered, contributing member of St. Anna Parish at the time of Application/Registration. Contributions through the envelope or online donation system must be a minimum of \$360 per year per family to qualify for the parishioner tuition rate.

If you are a practicing Catholic, you may qualify for an assessment from your parish. Please contact your pastor and the school office if you would like an assessment form. Active members from contributing parishes will have the parish reimbursement deducted when the money is received from their parish.

**Financial Aid is available. If you want to be considered for financial aid, you must complete the FACTS application process and apply online at <https://online.factsmgmt.com/signin/3H1T8>**

**by March 10, 2017.** Please understand that only those families who have completed these requirements by the stated deadlines will be considered eligible for financial aid. Thank you for your cooperation, and please do not hesitate to contact the office if you have any questions.

**TUITION FOR PREK3 AND PREK4**

The non-refundable \$125 registration fee also applies to the PreK3 and PreK4 programs and is due at the time of registering your child. Please note, the St. Anna Family discount plan does not apply to students in PreK3 or PreK4. It is implemented when your child enters Kindergarten.

The tuition rates for PreK3 and PreK4 are as follows:

## TUITION FEES GRADES K-8

Tuition rates for the 2017-2018 year are below.

Additional fundraising events are scheduled for the academic year and although they are not included in the tuition payment, families are encouraged to participate in as many events as possible since the additional revenue directly benefits our students.

## PAYMENT OPTIONS

There are options for tuition payments:

1. 3% discount available with complete tuition paid in FULL by June 1, 2017. Cash, check, or credit card payments through FACTS program will be accepted. Credit card payments are subjects to processing fees.
2. Payment in Full by July 1, 2017 by check or cash to the Parish office
3. Payment in Full by July 1, 2017 by credit card through FACTS program
4. 10 Month Payment Plan – Electronic billing system beginning in July and ending in April through FACTS.
5. A 3% per diem late fee will be charged on past due accounts.

## LATE REGISTRATION & WITHDRAWAL POLICIES

- Students who register after the beginning of the school year will be charged according to the number of months attended. Any part of a month will be counted as a full month of attendance when determining the amount of tuition.
- Students who withdraw after July 1<sup>st</sup> will be charged one quarter of the year's tuition for any portion of a trimester registered. Financial quarters are July 1<sup>st</sup> to September 30<sup>th</sup>, October 1<sup>st</sup> to December 31<sup>st</sup>, January 1<sup>st</sup> to March 31<sup>st</sup>, and April 1<sup>st</sup> to June 30<sup>th</sup>. The financial quarters are quarters registered and the academic year is based on trimesters attended. *Tuition due is based on financial quarters.*
